3 Contributions to training and service in the field

At the University of Ottawa, I have been the supervisor of three Master's students (Jean-Bruno Chartrand, completed in September 2011, Julie Barette, completed in September 2015, and Jérémie Beauchamp, completed in August 2017), I'm currently advising two doctoral students (Emad Alansary, writing a descriptive thesis on the Gurunsi language Bago, and Justin Case, writing on the typology of differential object marking). I have co-advised two doctoral students outside of Ottawa, Glauber Romling (Federal University of Rio de Janeiro, defended in February 2013) and Javier Carol (University of Buenos Aires, who defended in December 2011), both of whom have spent periods as visitors at the University of Ottawa, and have been in the dissertation committee of four doctoral students at Paris 7, Léia Silva (completed in April 2011), Adriana Estevam (completed in September 2011), François Copin (completed in September 2012), and Marta Pabón (completed in September 2017), and one at the University of Texas at Austin Adam Tallman, completed in August 2018. I have been examiner for fifteen doctoral and two Master's theses at the University of Ottawa, as well as two doctoral theses at McGill, one doctoral thesis at MIT, one Master's thesis at Carleton University, and one master's thesis at the Universidad Nacional del Comahue in Argentina. I've supervised one postdoctoral fellow at the University of Ottawa, as well as three visiting scholars.

I've taken a total of eight graduate and undergraduate students to Brazil for research in five trips since 2009, and currently teach a field course in the Amazon every two years with Canadian students. The last edition of this was in Ecuador in the summer of 2018. I have taught as a visiting professor in Argentina (Universidad Nacional del Comahue, most recently in 2017) and Brazil (Federal University of Rio de Janeiro, in 2013), and at non-credit summer schools in Argentina and Brazil.

In recent service, I have been responsible for the organization of a first international linguistics meeting in Paraguay in July 2017 (with the collaboration of the Secretariat for Language Policy of Paraguay), the 2018 Workshop on the Structure and Constituency of the Languages of the Americas, the Winter School in Aboriginal Linguistics (ELISA) in Santa Fe, Argentina, in July 2018 (with colleagues Cintia Carrió and Javier Carol), and (together with colleagues Martine Bruil and Anne Schwarz) the syntax-semantics workshop in the Amazonicas 7 conference in Ecuador in May 2018. I am currently the head of the Francophone Canadian Linguistics Olympiad for high school students.
